**Re: Security Council Renews Sanctions on Democratic Republic of Congo, Extends
Expert Group Mandate, Unanimously Adopting Resolution 2582 (2021)**

Dear Registrant,

The Compliance Commission wishes to inform that the United Nations Security Council Committee adopting resolution 2582 (2021) under Chapter VII of the Charter of the United Nations Council decided to renew until 1 July 2022 measures set out in paragraphs 1 to 6 of resolution 2293 (2016) pertaining to an arms embargo, travel ban and asset freeze. These measures require all States to refrain from, among other things, providing weapons to non-governmental entities operating in the Democratic Republic of the Congo.,
